OVERVIEW OF PERFORMANCE 2021


The number of fatalities in the South African mining industry regressed by 23% to 74 in 2021 as compared to 60 in 2020. This compares unfavourably with the 51 fatalities reported in 2019, the industry's best-ever safety performance.

The 2021 regression in fatalities was the second consecutive annual regression and the worst recorded since 2003 when tripartite stakeholders first agreed health and safety milestones.

Most fatalities occurred in the gold and platinum sectors, together accounting for 69% of fatalities. Only the coal mining sector reported a decline in the number of fatalities. General types of accidents (being struck, falling, drowning, inundation, mud rush, burning and scalding) were the cause of most fatalities, overtaking falls of ground whose contribution to fatalities has plateaued in recent years.

The number of serious injuries also increased in 2021, up by 11% to 2,014 – this followed an improvement of 25% in 2020.

RECOMMITTING TO ZERO HARM



Given the deterioration in 2021 safety performance, the Minerals Council and other key industry players recommitted to delivering on the 2024 safety targets agreed in 2014 and to continue working to eliminate fatalities and injuries. The Minerals Council Board furthermore approved eight-step CEOs intervention measures to urgently address the decline in safety performance.
